The public meeting was called to order and roll call was taken, as noted above at 7:37 pm.

Committee Reports:

Audit Committee: we will be approving the risk assessment report this evening. Haven't had a meeting.

Nutrition & Wellness Committee: met a couple of weeks ago and discussed how we want to make some improvements in the amount of time that kids have when eating lunch. It's something that we're looking at the bond committee in improving the design of the lunch serve lines so that students have more time to eat their lunches. We also talked about how close we came to getting the farm to school grant and how we want to try for it again especially with the feedback we received from SED about how to resubmit. It would be a wonderful thing to have. We also talked about the mindfulness pilot that's going on at Deasy and how the staff got an in-service workshop so that they could bring it to the rest of the classrooms next year.

Policy Committee: nothing reported.

Technology Committee: our last meeting of the year was on May 23rd. Discussed were the surveys on the 1-1 initiative that we sent out to the parents and teachers. We received positive responses and we encourage more people to complete the survey. We also spoke about our rollout of our chrome book initiative for next year for grades 6-10. The high school teachers will be getting their iPads over the next couple of weeks. We'll be offering insurance the beginning of July for the middle school students to cover the year so that it will allow students to bring their chrome books home for the summer. Insurance will also be offered for the incoming 6th, 9th and 10th graders for when they come to the orientation events held in August. A handbook will be added to the website as well as embedded into their chrome book which allows us to save on paper. We received our shipment of 900 chrome books and our tech department is working on preparing them and getting them ready for distribution. Cases are due to be received the last week of June. We're ordering Kensington charging stations for each classroom along with two ac charging cables for middle school 8th grade as well as 9 & 10th grades teacher classrooms. We'll also setup charging stations at the high school library as we have in the middle school library. We have met with a lot of our staff in the high school and they will be sustained with chrome book and issues will be addressed. Districts were asked to submit

technology plans to New York State for 2018-2021, our district is one of the first districts to submit their tech plan to New York State and it has been approved. It's posted on our website and the district technology page. All the guidance and input we got from everyone made this team effort very positive. As part as the Every Student Succeeds Act (ESSA), all districts will be required to have climate surveys completed in the near future. We participated in a pilot and climate surveys were completed in the middle school by parents and teachers. That was to prepare us for what's coming from New York State next year and in the future.

Bond Committee: met yesterday and spent most of the time going over the list of items that might be included in a bond that was put together by our architect and his team. Doing multiple walk thru's with the bond committee sampling everything that would be included, cost and how those numbers were reached. We'll be meeting again to starting thinking about what should be included in the bond.

Superintendent's Report:

During the PARP celebration I went to Landing school and read to Ms. DePace's class and I read about a group called the Jubilee singers. It's fiction based on non-fiction. The student's after we read the book talked about what it was like during those days for former slaves to finally be emancipated and go to a particular college. They looked up Fisk University from the time the book was written as well as what happens in modern day. They saw a particular poster that gave a summary of their research. The jubilee singers actually went out and performed to raise money to keep the school alive. We talked about our own experiences with chorus and the select choral and how they went to represent Glen Cove in places like Italy, the White House and most recently Florida. They asked me to share the poster with the select choral as a result the select choral went to Landing and after the general assembly they sat with Ms. DePace's class and did a question and answer. It was a delightful conversation with the students. Thanked Ms. DePace and her class. We're looking very closely before the end of the school year is a nine period day at the high school only. We don't have a nine period day in the schedule but we've hired with the board's approval someone to work in technical terms in the sandbox to bring a nine period day to at least the high school. The first year of implementation would take close to about five teachers. We're keeping a very close eye on enrollments through the elementary to ensure that we don't compromise class size. The high school guidance counselors along with high school administration has some indication as to what a ninth class would be and inclusive of what we would recommend for the first year would be to put the lab onto the math, science and English class for 9th and 10th grades. So that the extra help would be included during the school day. More will come at our next board meeting.

- *Trustee Nedbor-Gross* requested the summer projects list from buildings and grounds.

Unfinished Business

- *Trustee Juarez* wanted to address the ivy that's still growing on the back of the

middle and Deasy schools. I was told it was taken care of and it's not wrapping around what looks like a hot vent pipe. What are we doing about the tennis courts? They're pretty bad.

- *Trustee Alexandris-Miller* stated that the tennis courts are one of the items on the list for the bond.
- *Trustee Nedbor-Gross* also wants the tennis courts addressed before a bond is even put up for vote as well as the basketball court over there. These are school grounds, high school playground and needs to be addressed sooner, we can't wait for the bond to be proposed or approved. This cannot wait. They're safety issues.

Public Participation

The following topics were presented during the public participation section on non-agenda or any other items.

- Just want to make a mention that we had our mediation session this evening. We've waiting five months for this meeting. We came to the table with all good intentions to try and come to an agreement and this board had five months to discuss what they could offer. It was very disheartening that we really moved at the table, we pretty much crossed everything off our list except for some monetary requests going forward and we were told by the mediator that the district was unprepared to really give us any monetary offer because they didn't know what it was yet. They had to talk to their business person and that we couldn't further the discussion because the board needed to talk a little bit more. I understand that maybe they needed to come back to you and have a discussion but I will tell you that we're almost a full year with an expired contract and by what's been going on people are getting very frustrated. You should know the history of what we've gotten over the past years. I will send it to you when I compile the nice summary of zeros that we've gotten and the small little crumbs that we've gotten over the rise in health insurance costs. We have a large staff here that works very hard and we are really hoping that you will do all you can to wrap this up by the end of this school year. No one likes coming to work with these shirts on and it does demoralize the staff. If you want to have quality teachers stay here and giving their all to the students and this community you really need to wrap this up. We all know what the bottom line is going to be. I've been doing this a long time. We know what it's going to be. It has to get done. So please stop dragging it out, those of you that have the control to get it done, it time to get it done. Thank you.
- I come from a family of educators. I've lived through union negotiations from when my father was a teacher getting paid next to nothing and volunteering for things. What I hear here is teachers wanting something and we don't know what that is. We don't know if it's what they should get and we don't know whether the district is not giving them what they should get. We have no way of knowing. My comment is it's the people's money and people should know. We don't have a lot of money in this district so it's a difficult situation. If part of the reason we don't know is because the contract calls for this kind of thing being private then my opinion is too bad. The bussing that we don't have for the students that went over to NY Tech this year and might go over to Molloy. Is that because if we bus those kids we would have to pay for students who go out of the district pay for them also and therefore the money is something we don't have to do? Is the appointment of the drum line instructor someone new?
- The idea of the nursing exchange program is much like what you do with student teachers. You send them off to the school and they get to see what it's like in the classroom. I have a teaching certificate in Texas for grade school and it's expired because I haven't been there for many years. This is what you have with robotics and I wish you would do this with more programs because you give them a chance to see what it's really like to be involved in something like that. The point is that they get to see it and they get to make a choice. If you don't send them out they might not go to nursing school and they may be the best nursing people in the world. This is a great opportunity and you should pursue this type of thing especially since the interchange is after school hours and gives everyone a chance to interact and would improve the education system here.
- I haven't been up here in a while. I've been trying to let thing progress naturally but they haven't been. Mr. Juarez brought something up at the last meeting and it went completely unanswered. A year February at a board meeting at Gribbin, before livestreaming, all of you assured me that once the greenhouse got approved

by New York State you would do everything in your power that it would get installed. Maybe you agreed because you thought it would be approved. I haven't brought it up because I know you had asked Ms. Santoro to put together another list of licensed and insured volunteers but still nothing has progressed. Our meeting was setup a couple of months ago which was canceled and never rescheduled. In one of my many emails I begged you to get it installed before my daughter entered kindergarten, she was just born in 2012 when this all started. She's done with kindergarten and still nothing not even a proper update. My daughter has Ms. Comola who's a wonderful teacher, do you know what Ms. Comola would've been able to teach her class with the greenhouse right outside her door? Another year of wasted opportunity. The science coordinator's daughter is in that class as well. I don't even know if Ms. Doeschner knows that there's a greenhouse sitting in a storage container a few hundred feet from her child's class. I feel that if I don't bring up the greenhouse no one else talks about it. I almost brought it up to Tom Suozzi last week at the picnic because we had discussed it last year but I didn't want to dampen his celebration. The biggest struggle for the PTA is to advocate for the children. They also go above and beyond to supplement educational opportunities that the district budget does not include. Including playgrounds, greenhouses, field trip, cultural arts events, which many districts don't need to fundraise for as they provide them. We work very hard to fundraise for these things and when they don't get utilized in the way they're intended or in a timely manner it makes the parents, families and pta's feel that our efforts are not valued. As for the Connolly playground I understand that the children got the go ahead to start playing on it yesterday. Thank you for realizing that the parents should not be responsible for someone to remove the gravel. On April 19th after the playground had already been into the ground Viktor had a meeting to find out where the boarders would go and it would take 3-4 weeks for them to come in. That meeting should have happened months before. One of the reasons the playground was order before the holidays was so that the 5th graders could utilize it. The same group that fundraised for the greenhouse and now they have three whole weeks to use the playground when they could have had two months. It makes me sad and sick to my stomach actually that these monumental efforts to acquire these big purchases are taken for granted and wasted. I really try to be involved and help wherever I can and even be one of the two parents that come to these meetings instead of tucking my kids into bed. I don't know why I'm trying so hard. It's not like I'm benefitting my kids or any of the kids. We're not respecting our teachers, we're not doing what we can to hire good nurses, were not appreciating the families that make up this district. It's very frustrating. As far as the board goes I know you have the best of intentions and when you get up there they're a ton of important things that we don't know anything about but please remember why you chose to be there and hopefully it's to help the children and make our school district great. At some point soon, my husband and I will have to renovate or move because we've grown out of our house. The big question will be do we stay in Glen Cove or go somewhere that has more opportunity for our children in a district that utilizes and appreciates our efforts. Please tell me something positive and hopeful that will help me not to have to ask that question. Thank you.

Trustee Nedbor-Gross requested an update by the next meeting on the greenhouse as they have not seen anything in a long time. Since we haven't had a facilities committee or meetings of any sort.

Trustee Juarez stated that he whole heartedly supports our board. I just want everyone to understand, at least for myself. I keep hearing that the board is dragging their feet, the board's not moving forward, I don't see where this is happening but I would like to know about it. The same way I would like to hear about it from parents and students. You're the ones sitting in the classroom. I've set this before. If there's anything out there that someone would like to bring to my attention, I'm all ears. If in private I would share with the board so that we could move forward. The last couple of weeks have been very hectic to say the least and I think the only thing that's been happening in my opinion is that the board's divided. It's divided our community, it's divided administration and I would like I'm sure with the rest of the board and community would like to come back together and work forward as a group. So if there's anything that anyone wants to discuss I make myself available.

Trustee Nedbor-Gross mentioned that *Trustee Field* has requested at previous meetings for plans on the proposed bleachers. We never received a copy of those plans.

On a motion by *Trustee Alexandris-Miller*, seconded by *Trustee Nedbor-Gross*, the Board unanimously (4-0) moved to adjourn the public meeting at 8:50 pm.
